SECTION 4) FIRST-AID MEASURES

Inhalation

SECTION 5) FIRE-FIGHTING MEASURES

Suitable Extinguishing Media

Fire-fighting Procedures

Emergency Procedure

General

Eye Protection

Skin Protection
